1. I promise to take with me during the whole duration of the competition, the obligatory material and to exempt the organization in the event of accident or illness attributable to the lack of mandatory equipment provided;
2. to be aware that the mandatory equipment is as follows: a) backpack or fanny pack b) water bottle or camelbag c) glass or other container suitable for drinking at the refreshment points d) and food reserves) thermal blanket f) whistle g) adhesive elastic band suitable for a bandage h) waterproof or windproof jacket designed to withstand conditions of bad weather at altitude i) hat or bandana l) mobile phone m) headlamp;
3. to agree to the mandatory equipment checks may be made at any time of the race and to be aware that a lack of even one of the required materials from the equipment I brought to the travel can determine my suspension and I accept the 'sole discretion of the organization members responsible for monitoring;
4. to exempt the organization "ETNA TRAIL A.S.D.", the race director and the head of the path from any and all liability for damage to property and people, including personal injuries and / or death.
